# A Reminder: Town of Wethersfield Tax Exemptions for Veterans

Veteran's exemptions are available to Wethersfield residents as of the October 1<sup>st</sup> assessment date for those who served during one of the state mandated dates of war or military campaigns as well as received an Honorable Discharge (DD214 must be filed with the Town Clerk's Office by September 30<sup>th</sup>).

Exemptions are based on certain qualifying conditions, with additional benefits granted to Veteran's with a VA disability rating or low income (State mandated income limits and proof required). Deceased Veteran's spouses will continue to receive their benefit until re-marriage. Additionally, if you are a CT resident on Active Duty, you may be eligible for the total exemption of one passenger motor vehicle.

### **Mental Health Services for Veterans**

The psychological challenges of readjusting to home are ever present for Veterans returning from military campaigns involving war, from Vietnam to more recently, Afghanistan and Iraq. Veterans continue to face barriers to mental health treatment including stigma, shame, and lack of understanding, as well as logistical barriers such as long wait times and travel distances. The National Veterans Foundation reports that many of the crisis calls that counselors handle begin with issues of isolation and loneliness. These issues can be flags for developing mental health conditions, substance abuse, or suicide. Due to the high rate of Veteran suicide, suicide prevention is the Veteran's Administration's highest clinical priority.

The 988 Suicide & Crisis Lifeline is a United States-based suicide prevention network of over 200+ crisis centers that provides 24/7 service via a toll-free hotline to anyone in suicidal crisis or emotional distress. Just dial 988. For more information visit 988lifeline.org

For Wethersfield Veterans, the **Hartford Vet Center**, located 25 Elm Street in Rocky Hill, is a convenient location to receive counseling for mental health concerns, as well as alcohol and drugs, bereavement, and military sexual trauma.

Other services include employment counseling, benefits assistance, referrals to

community agencies and liaison with VA facilities. Services are also offered through Mobile Vet Centers, virtual appointments and at other community locations.

### **Forever in My Heart Foundation**

Are you a disabled military Veteran who might benefit from the assistance of a Service Dog? The Forever in My Heart Foundation was founded to make an impact in the lives of homeless dogs in animal shelters and disabled military Veterans in our communities. Dogs are trained to be of service to disabled Veterans.

## The PACT Act and Camp Lejeune

The PACT Act is a new Federal law that expands VA health care and benefits for eligible Veterans exposed to burn pits and other toxic substances including the Camp Lejeune Water Contamination Health Issues. This law helps provide generations of eligible Veterans and their survivors with the care and benefits they have earned and deserve.
